As the Central APDA could not recruit part time staff the minutes of the each meetings of the Central Executive Body could not be sent to the districts and I am sure the District Unit will bear with us. However, I take the privilege to inform that the current Central Executive Body (CEB) stands united and all decision pertaining to the APDA are adopted through resolutions. The following activities were done since the current CEB took office on May 2011.

1. Ground Preparation for strengthening of APDA Central:
  - a. Assuming charge and informing all District units and all HODs of new CEB (*Ref. press release*).
  - b. Appointment of 'Advisors to APDA Central' for the period 2011-14. Advisors:
    - i. Dr. M. Jini (Supertime Specialist/CMS)
    - ii. Dr. Gyati Tatu (Addl. DHS)
    - iii. Dr. Tojum Lollen (DDHS)
    - iv. Dr. B.V.S Murty(DDHS-AYUSH)
  - c. Appointment of legal advisor: Mr Sunil Mow, BA(Honours), LLB (*Ref. Press release 16-07-2011*).
  - d. Met the Hon'ble Health Minister, Secretary (Health & Family Welfare), DHS, ADHS and briefed regarding the formation of new Central Executive Body (CEB) and 'Resolutions' of the General Body of the APDA (*Ref. Press release dated 16-6-2011 & 24-6-2011*).
2. Activities taken up:
  - a. Submitted Memorandum to the Hon'ble Health Minister and Secretary (Health & Family Welfare) of the resolutions adopted by the General Body of the APDA (*Ref. [www.apda.org.in](http://www.apda.org.in)*).

- b. Constitution of 'Sub-Committee' headed by Dr. Mari Basar, Surgical Specialist to address issues pertaining to the GDMOs with PG Degrees (Ref. [www.apda.org.in](http://www.apda.org.in)).
  - c. Discussed with the Govt for expediting the DPCs for the TBP and for conduction of the future DPCs on annual basis.
  - d. Appealed with the Hon'ble Health Minister for:
    - i. En-cadre post of the DHS to be exclusive for the Senior Administrative Grade Officers of APHS only and not for the IAS Cadre as proposed by the Chief Secretary (Govt. of A.P)-*assurance obtained from the Minister, however constant vigilance on Govt. moves required.*
    - ii. Amendment of the APHS cadre rule 2000 as per the Dr. B.V.S. Murty Sub-Committee report and creation of post for the Principle Director and the Director Medical Education (DME).- *file endorsed by the Minister, Secretary (Health) is at Health Directorate for put up; currently on move.*
    - iii. Implementation of various resolutions of APDA submitted through the Memorandum (Ref. [www.apda.org.in](http://www.apda.org.in)). *APDA Central decided to break up the topics and approach with the govt for implementation. Each topic has been assigned to each Central Executive member for execution.*
  - e. Opposed to the posting of new recruited Radiologist and Surgical Specialist to Rama Krishna Mission Hospital on deputation violating all deputation norms and undermining the State Health Services-*Matter accepted by the Govt. and currently withdrawn.*
  - f. Demand for arrear for the recent TBP and holding of next DPC for those doctors left out due to non-availability of the ACR.-*file on move with the govt; had series of discussion with the Secretary Health (Govt. of A.P) and Deputy Secretary. All APDA members are requested to submit the ACRs in time so that fight for timely conduction of the DPC is materialized.*
  - g. Relaxation of APDA Membership registration fee to Rs. 1000/- till 31<sup>st</sup> September 2011-Widely circulated to all the District Units through DTOs of the District-*only few applications for registration have been received so far.*
  - h. Conducted 'CME cum Celebration of Doctors day' on July 1<sup>st</sup> 2011. (Ref. [www.apda.org.in](http://www.apda.org.in))
  - i. Conducted 'Blood donation camp' on blood donors' day on 14<sup>th</sup> June 2011 (Ref. [www.apda.org.in](http://www.apda.org.in)).
  - j. Asstt. Auditor of the APDA Dr. Ani Siram has been posted to Ziro District Hospital, Lower Subansiri District as Junior Specialist. We are currently negotiating with the government for his placement back to the State Hospital, Naharlagun.

3. To be taken up:
- a. Request for financial assistance by Dr.(Mrs) Sreemoyee Demo, SMO(SG) could not be materialized as the Central APDA could not verify her permanent registration number. The matter has been informed to District Unit, West Kameng to verify her registration number and to intimate the Central Unit for further necessary action. This is because such assistance at individual level is the privilege of only the Registered APDA members.
  - b. To bring up 'Periodical review of the APDA'-soft copy/hard copy. Review will contain activities of the Central/District Unit APDA, research works of the APDA members, Scientific advances etc.
  - c. Wide range of issue those still pending implementation/completion.
  - d. Issues as on when arises.
