In exercise of the powers conferred by clause (4) of Article 16 and in terms of Article 335 and 320 (4) of the constitution of India, the Governor of Arunachal Pradesh is pleased to make reservation in matters of promotion of following classes of posts as shown below for A.P.S.T officials and officers in the services under the Govt. of Arunachal Pradesh.

1.	Group	'A'	50%
2.	Group	'B'	80%
3.	Group	'C'	80%
4.	Group	'D'	100%

To facilitate proper implementation of the government decision in this respect, a model 100 point roster indicating appended at Annexure- I & II for strict compliance by all concerned.

Separate order will be issued in the matter of determination of seniority.

This Notification shall come into force with immediate effect. All such cases of promotion, which have not been given effect to, shall be subject to the present notification.
