Office Memorandum

Dated Itanagar, the 17th October 2001

Reluctance of Doctors, nursing & Para medical staff to serve in interior locations has been seriously affecting delivery of Health Services at various service delivery points like Sub Centres, Primary Health Centres, Community Health Centres and a number of District Hospitals. In order to overcome this handicap, the Governor of Arunachal Pradesh is pleased to order that, henceforth, there shall be compulsory rotation of Doctors, Nursing & other para- medical staff of the Dept. at various locations on completion of prescribed tenures as per classification of locations detailed hereunder:

- Category – ‘A’** Category ‘A’ will consist of two General Hospitals, all District Hospitals, Community Health Centers, and Sub – Centres connected by all weather roads. The normal tenure at such locations may not exceed 4 (Four) years
- Category – ‘B’** Category ‘B’ will consist of such locations as are connected by roads but which are not all weather. The normal tenure of posting at such locations may not exceed 3(Three) years.
- Category – ‘C’** Category ‘C’ will consist all such locations as are not connected by roads and entail foot marches. The normal tenure of posting at such locations may not exceed 2(Two) years.

Rotation of Officers and staff for ‘B’ & ‘C’ locations shall not be dependent upon posting of relievers unless incumbents represent for their continuance beyond normal tenure of posting in order to avail of preferential treatment for nomination for post graduate courses in terms of Office Memo No. MEST- 2000/44 of 2000
