## Circular

Recently there had been much confusion that arose at most of the District Unit regarding the **yearly membership fee** and the onetime **APDA Membership Registration fee**. It has been stated that some had paid the Registration fee as well but have not received the Registration letter or Identity card. Others are confused between these two. It is therefore; hereby clarified that one time APDA Registration fee is Rs. 2000/- (Two thousand only). Whereas, the yearly membership fee stands as usual this is collected on yearly basis. This money is audited and remains with the Central APDA to be used in the interest of the APDA as a whole.

To clear these confusions once for all the Central APDA decided to:

1. Relax the APDA Membership Registration Fee to Rs. 1000 (one thousand only).
2. Those who had submitted the required amount already through their District Unit, the concerned District Unit are requested to verify and endorse their claim on their duly filled application form along with 2 recent Passport Photos.

The application form is available on APDA Website: [www.apda.org.in](http://www.apda.org.in). However, this relaxation is **valid till 30<sup>th</sup> September 2011 only**. Any applicant after 30<sup>th</sup> of September 2011 will have to pay the usual amount of Rs. 2000/- (two thousand only) as APDA Membership Registration fee.

Members are request to hurry to avail this rare opportunity.
