ORDER

The Specialists posted in General Hospitals and District Hospitals may be exempted from emergency duties. However , they will be on call for 24 hours a day.

The functional specialists posted in District Hospitals and General Hospitals will also be exempted from emergency duties provided there are no regular specialists working in the particular subject in those hospitals. However these functional specialists would also be on call for 24 hours a day.

Specialists and functional specialist posted in CHCs and PHCs will also attend emergency duties.

All the programme Officers will also attend emergency duties to the extend of 25% attended by the other regular Medical Officers. The above decisions have been taken so as to expose the programe Officers to the various disease and problems which may also be related to their programme so that they are kept updated. If the emergency duty concides with the meetings, trainings, official tours etc the programme officers should be spared for such programme related activities and regular MOs should be made to replace them in emergency duties. However in lieu of such exempted days, the concerned programme officers will have to undertake emergency duty on another days.

It was also decided that DRCHOs / DFWOs will remain under the administrative control of District Medical Officers though they report directly to the Mission Director(NRHM) functionally. All the files related to programmes should be routed to the Deputy Commissioners (Chairman of the District Society) through the District Medical Officers(Vice Chaiman).

This above order is being implemented w.e.f 10th October '2008.
