PRESS RELEASE

In view of the failure of the state Govt. to initiate any action to the demands of APDA which was submitted on 28th June 2010, the APDA has decided to launch “**The First- Phase**” state-wide democratic movement w.e.f **9th August 2010**. The modalities of the protest have been informed to the executive members of all the district units.

The APDA is aggrieved by the lackadaisical attitude of the Govt. The Govt. has not even conducted any inquiry by an independent body leaving aside fulfilling our demand.

Further, the APDA has decided to move NATIONAL HUMAN RIGHT COMMISSION, NEW DELHI demanding action against the erring Police Officer and suitable compensation for human right violation and impingement of the fundamental rights of Dr Tana Talin Tara as guaranteed in the constitution of India to its citizens.

The APDA contemplates to seek disciplinary action against the Medical Officer (General Hospital, Naharlagun) who examined Dr Tana Talin Tara on 21st June 2010, if he has not properly followed the medico- legal protocol, negligence to duty, professional misconduct etc. while medically examining Dr Tana Talin Tara.

The APDA, appeals to the general public to bear with inconveniences’ to the patients that may arise during the proposed democratic movement and understand the circumstances compelling the association to take such steps.
