

**Following Resolutions have been passed during the 7th General Conference of
APDA on 23rd Nov' 08 under the Chairmanship of APDA President
Dr Gyati Tatu at Banquet Hall, Itanagar.**

- 1. Creation of 3 (three) Director Posts**
 1. Director of Medical Education
 2. Director of Family Welfare
 3. Director of Administration.
 - All the North-East states and other states of the country are having separate Director of Medical Education, it is only our state not having such Directorate, hence the Members urge for creation of separate Director of Medical Education in the state.
- 2. Appointment of Health Commissioner/Health Secretary.**
 - The Appointment of Health Commissioner/Health Secretary should be from APHS cadre.
- 3. Mission Director (NRHM)**
 - The Mission Director (NRHM) should be from the Health Cadre or if at all from general administration then. He/She should not interfere /encroachment in the establishment matters to Director of Health Services.
- 4. Appointment of Medical Officer or Specialist** should be conducted every year through Arunachal Pradesh Public Service Commission. Regarding this point of Sub-Committee will be formed to review the existing RR Rule (APHS CADRE).
- 5. Creation of Forensic Expert to all the district hospitals/General Hospital** or interested in service doctors in Forensic Medicine may be sent for Re-fresher Course.
- 6. Implementation of 6th Pay Commission as per Central patterns.**
- 7. Regular transfer / posting of MOs / Specialist should be done every 5 (five) years** regarding this point Sub-Committee will review and moreover the Committee will decide or categories the hard/soft place of posting.
- 8. Appointment of Medical Superintendent Post to all district hospital with DDO Power** according to APHS Cadre Gazetted. The post of Chief Medical Superintendent Post of General Hospital Naharlagun and Joint DDHS. Pasighat must be implemented in too according to APHS Cadre Gazetted.
- 9. Creation of Specialist Post of different subjects in all districts hospitals, General Hospital.** The doctors having PG Degree to be absorb in specialist post strictly on seniority basis.

10. **The ACR of Doctors should be reported by the DMO and Reviewed by the DHS Naharlagun instead of DC.**
11. **The conveyance allowance & Post Mortem duty allowance.**
12. **Separate pay scale of DMOs will be review by the Committee.**
13. **House Rent Allowance.** The HRA should be given to doctors at par with Central pattern who have not been provided Govt. Qtr.
14. **Change of designation of SMO (SG) to CMO.**
15. **All the MOs should be given Account and Administrative training in due course.**
16. **Registration with APMC** Compulsory registration of all service doctors in A.P Medical Council should be encouraged.
17. **Transparency of expenditure statement.** The expenditure statement of Central APDA. The Executive Body should be properly explained and a copy of statements should be highlighted to the district units APDA.
18. **Regular CME** should be conducted for all the doctors to update the development in Medical Science.
19. **Appointment of Programme Officer / DMO should be as per seniority basis.** To implement this promotional scope the Sub-Committee will form by the APDA.
