

**RESOLUTIONS ADOPTED DURING THE GENERAL BODY MEEETING OF APDA
AT HOTEL ACHI-AMA, NAHARLAGUN ON 11.03.2010**

The following resolutions where adopted:-

- 1 Memorandum to be submitted to the Govt. by the Central Executive Body, APDA demanding **immediate cancellation of appointment of Dr L. Bagra, SMO as DMO Seppa, East Kameng.**
- 2 Memorandum to be submitted to the Govt. by the Central Executive Body, APDA demanding **immediate cessation of direct recruitment of Doctors from NRHM and Contractual services by- passing APPSC.** All recruitment of doctors should be as per the APHS Rule 2000.
- 3 To resort to **democratic movement or seek legal help** if the Govt. fail to fulfill the above two demands.
- 4 The **Central Executive Body is empowered by the District Units** to seek legal help on behalf of the members if it is deemed necessary.
- 5 The Central Executive Body will appoint/select **one Legal adviser/expert** for the APDA.
- 6 **To raise Legal Fund.** All members to contribute one time, initially **Rs. 500/-(Five Hundred)** each. This money will be used exclusively for legal activities. Collection of fund for legal expenses should be started as early as possible
- 7 Appointment/promotion to **all the administrative and program post (both Cadre and Ex- Cadre)** should be through proper DPC taking into consideration all eligible candidates as per APHS Rule 2000 and other relevant rules. The Govt. should review the present incumbents and streamline it at the earliest. Suitable representation should be submitted by the Central Executive Body to the Govt. to this effect.
- 8 The Govt. should reserve sufficient number of seats for the in-service MO with PG degree in the recruitment of Specialists. This should be highlighted in the recommendation of amend mend of APHS Rule.
- 9 To mobilize fund for financial assistance to **Dr Genden Tsering, Dental Surgeon, Jang, Tawang Dist;** who is about to undergo Kidney Transplantation. All members will be requested to contribute generously.
